I am fully aware of and hereby agree to comply with the grid regulations, limitations and restrictions and am aware of and agree to abide by the restriction on sandblasting on the grid or performing water blasting with pressure that may result in removal of paint. **I understand that if convicted of a violation as defined in Homer City Code Chapter 10.08, Protection of the Harbor and Waterways, I would be subject to applicable fines stated therein. In addition to the requirements set forth in this chapter, certain federal, state, local, and international laws and regulations, including but not limited to environmental, health, safety and sanitation laws and regulations, are applicable to the Homer Harbor and waterways in the City. All persons are hereby warned and placed on notice that they are responsible for determining their obligations under such laws and that they may be subject to applicable penalties, fines, imprisonment, and other forms of liability for violation of such laws and regulations.**

I hereby verify that all the information I have given concerning the above vessel is true and correct to the best of my knowledge and that I shall be held responsible for any inaccurate information I have given above. I hereby agree to remove all debris and trash resulting from my use of the grid prior to departing the grid.
